- 1) **RESEARCH** all their options for college at [LearnMoreIndiana.org/preadmit](http://LearnMoreIndiana.org/preadmit).
- 2) **SUBMIT AN APPLICATION** to secure their admission to any of the colleges above. Note: Each institution may have more conditions to secure their admission. They can access each college's application and other details by scanning the QR code. (You can also visit the link above.)
- 3) **APPLY TO OTHER COLLEGES OF INTEREST** in Indiana. Visit the link or scan the QR code to access application links.
- 4) **CREATE THEIR FSA ID** in preparation for filing the Free Application for Federal Student Aid (FAFSA). Indiana has more than \$400M in state financial aid, and there is federal and campus-specific aid, too. Flip the page for more information.
- 5) **MARK THEIR CALENDAR** to file the FAFSA in December. They can **sign up for a reminder** at [LearnMoreIndiana.org/FAFSA](http://LearnMoreIndiana.org/FAFSA). Click on "I need help filing."

# HOW TO FILE THE FAFSA?

## What is the FAFSA?

The Free Application for Federal Student Aid (FAFSA) is the most important document for getting money to help your student pay for college. Financial aid is the term used for that money. It comes in the form of grants, scholarships and loans.

**To enroll in college in fall 2024, your student will file the 2024-2025 FAFSA.** That FAFSA will open in **December 2023**. To qualify for Indiana's state financial aid, your student must file by **April 15, 2024**.

When it is time to file the FAFSA, *the parent(s) and their student* will need to create a **Federal Student Aid ID (FSA ID)**. A *legal guardian* of a student does not.

## Resources needed to create an FSA ID:

1. Your Social Security number (SSN)
2. Your full legal name
3. Your date of birth
4. Your mailing address
5. An e-mail address that is unique to you (personal e-mail, not work e-mail)
6. A memorable username and password (store them somewhere safe)

## Resources needed to file the FAFSA:

1. Your FSA ID username and password
2. Your Social Security number (SSN)
3. (Optional) Your driver's license number
4. Your 2022 federal tax returns, if applicable (IRS forms 1040, 1040EZ or 1040A)
5. The 2022 federal tax returns for your student (if applicable) (IRS forms 1040, 1040EZ or 1040A)
6. Records of money earned, including W-2 forms and recent bank statements
7. Alien registration numbers or permanent residence cards, if you are not a U.S. citizen
8. Six-digit FAFSA codes for any institutions your student is applying to. Use these codes to send your student's FAFSA information to the colleges. Your student will be able to add up to 20 colleges at a time. Find the FAFSA codes at **LearnMoreIndiana.org/preadmit**. (You can also scan the QR code on the front side of this letter.)

## How do I file the FAFSA?

The easiest way to file the FAFSA is online at **<https://studentaid.gov/>**. The website also provides a printer-friendly PDF if your student prefers to mail their FAFSA or a parent signature form is required.

During parts of the year, there are two FAFSAs open at the same time. Make sure that your student files the 2024-25 FAFSA.
