

FAFSA?

The Free Application for Federal Student Aid (FAFSA) is a form current and prospective college students complete to determine their eligibility for federal, state and institutional financial aid.



Filing the FAFSA can help make the cost of obtaining a college degree or postsecondary credential manageable. Hoosiers benefit from having education and training beyond high school because both unlock doors to job security and economic opportunity.

How do I file?

To file the 2025-2026 FAFSA, students and families must use **2023 federal tax information**. The FAFSA can be completed in two ways:

- At studentaid.gov
- On the paper application

Filing online is recommended when possible, and the FAFSA is free!

When do I file the FAFSA?

Indiana students should prepare to file a FAFSA between **October** and **April 15** of their senior year of high school and each year they plan to attend college.

Some institutions have FAFSA deadlines that fall before the state deadline of April 15, so students should check with their college or university to verify their deadline.

What do I need to file?

- A studentaid.gov account for students and parents (can be created at FAFSA.gov)
- ✓ Student and parent social security numbers (or alien registration numbers)
- ✓ Parent and student 2023 tax records, records of assets, and untaxed income
- ✓ List of schools to which you wish to send your FAFSA information (up to 20 online)
