## **PARENTS of Scholars**

As a 21st Century Scholar, your child must successfully complete the Scholar Success Program.

### What is the Scholar Success Program?

The Scholar Success Program (SSP) is a set of **12** activities for your child to complete in high school designed to prepare them for college and career success and keep them on track for their 21st Century Scholarship.

### What is ScholarTrack?

ScholarTrack is the tool for Scholars to track completion of SSP activities. These activities must be completed and logged in by June 30 of your child's graduation year. Learn more about the SSP activities, and create a ScholarTrack account with your child using the QR code:

### How can I help my Scholar?

Read through this guide with your Scholar and make a plan together for finishing this year's activities.

#### As a 21st Century Scholar, you have taken the Scholar Pledge to meet the following requirements:

- ✓ Complete the Scholar Success Program in high school and in college, which includes activities each year to help you stay on track for college and career success. The chart below shows the 12 activities that you must complete by high school graduation.
- ✓ Graduate from a state-accredited high school with a minimum of a Core 40 or an Indiana Diploma (Class of 2029 and beyond) and a cumulative grade point average (GPA) of at least 2.5 on a 4.0 scale.
- ✓ File the Free Application for Federal Student Aid (FAFSA) by April 15 as a high school senior and each year thereafter until you graduate from college.
- Apply to an eligible Indiana college as a high school senior, and enroll in college as a full-time student within one year of high school graduation.

- Maintain Satisfactory Academic Progress (SAP) standards established by your college.
- Complete 30 credit hours each year you are in college to stay on track toward earning your degree on time.
- Do not use illegal drugs, commit a crime or delinquent act or consume alcohol before reaching the legal drinking age.
- All grade-level activities must be completed by June 30 following the end of the school year.

### Visit a College Campus

Visiting college campuses is the best way to get a feel for what schools are really like and to find out if they would be a good fit for you.



### Take a College Entrance Exam

A college entrance exam is a standardized test that assesses college readiness.



### Search for Scholarships

A scholarship is a type of grant that supports funding your education and does not have to be paid back. Scholarships you earn can help cover expenses not covered by your 21st Century Scholarship.

### STAY ON TRACK WITH SCHOLARTRACK

ScholarTrack is an online tool that will guide you through the Scholar Success Program. You'll be able to manage your progress throughout high school and college and find resources to help you complete the requirements.

### Keep your contact information updated

Each year, you will receive information and resources to help you stay on track. If your contact information changes or you change schools, log in to your ScholarTrack account and make the necessary updates.

### Don't have a computer?

If you do not have a computer with internet access at home, use a computer at school, a public library, friend's house or talk to a parent or teacher/counselor for help finding internet access. ScholarTrack is also available on your smartphone.

### GET STARTED

Go to ScholarTrack.IN.gov. Register for an account and select "I am a student." Students should be ready to enter their name, date of birth, email address and Social Security Number (SSN), Student Testing Number (STN), or Scholar ID.

### **CREATE AN ACCOUNT**

Students can create a full or limited account.

- Full account Requires a SSN or STN and allows full ScholarTrack access.
- Limited account Requires a Scholar ID and grants access to log SSP activities. You can upgrade to a full account at any time.

### START TRACKING

Check your email to make your password. From the dashboard, select "Checklist," and then click on "11th Grade."

# Visit a College Campus

### College visits give you the opportunity to tour campuses and get a feeling of what campus is really like!

### Why are campus visits important?

Exploring a college through its website, brochures or videos only gives you a partial picture of what each school is like. However, visiting a school and touring the campus will give you a better idea of whether a school is a good fit for you.

### Tips for making the most out of your visit

**1. Ask questions!** Whether you think of questions before or during your visit, make sure to ask to learn more about the school you're visiting.

**2. Talk to individuals on campus.** This could include faculty members, academic advisors, admissions staff and current students.

3. Explore what is available for 21st Century Scholars. Visit Scholars.IN.gov/students/college to learn more, and make sure to ask your campus tour guide about specific Scholar programs and resources!

**4. Take notes** on your visit and reach out to the institution with any follow-up questions.

#### Get started

- **LOG IN** to your ScholarTrack account at **ScholarTrack.IN.gov** and select "Checklist" on the homepage.
- 2. CLICK on "Visit a College Campus" and preview the questions you'll need to answer about your activity.
- **3. CREATE** a list of schools you want to visit, then contact the school's admission office or visit their website to schedule a tour. Don't forget, touring different schools will help you find the best fit for you!
- **4 RETURN** to your ScholarTrack account and follow steps 1 and 2 to submit your answers after your campus visit.

#### Did you know?

If you can't do an in-person tour of a campus you're interested in, many schools offer a virtual tour, and it'll satisfy this requirement. Check out the admissions websites of the schools you are interested in more details!

## Take an Entrance Exam

### Entrance exams are an admissions requirement at many postsecondary schools.

### The most common exams are the SAT and the ACT.

- The SAT exam focuses on reading and math (multiple choice questions) and has optional writing and subject tests.
- The ACT focuses on English, math, reading and science.

Before you sign up for either exam, make sure you choose the one that best fits your needs. Some programs and schools require or prefer you to take a particular test. Check with your preferred schools' admission websites to see which test you need.

**NOTE:** If you're planning on attending a school that doesn't require an entrance exam, you still need to take one to satisfy your 21st Century Scholars requirement.

### How can I prepare for the exam?

#### Like any test, getting familiar with the content and studying goes a long way!

ASK your teachers, counselors or mentor what your school or community offers.

**VISIT** your local library to find ACT or SAT prep materials and practice books.

**CHECK OUT** test prep websites for free practice tests, test day tips and other resources to help you prepare and improve your skills. Visit ACTStudent.org or CollegeBoard.org.

**NOTE:** Both the ACT and SAT have a registration fee, but as a 21st Century Scholar, you may qualify for a waiver. Before signing up, talk to your counselor.

### LOG IN to your ScholarTrack account at ScholarTrack.IN.gov and select "Checklist" on the 1. homepage. **CLICK** on "Take a College Entrance Exam" and preview the questions you'll need to answer 2. about your activity. **REGISTER** to take the ACT or SAT during the spring of 11th grade with the links below. 3. ACT - ACTStudent.org/regist/ SAT - CollegeReadiness.CollegeBoard.org/SAT **PREPARE** for your entrance exam. For help, check out "How can I prepare for the exam?" on 4\_ the previous page. **TAKE** your entrance exam. When you register for your exam, you'll be given instructions 5. on where to go to take the exam, when to arrive and what to bring with you. Follow these instructions to make test day as smooth as possible. **RETURN** to your ScholarTrack account and follow steps 1 and 2 to submit your answers to 6. complete your requirement.

## Search for Scholarships

Scholarships can help pay for additional college expenses and do not need to be paid back.

### Why do I need to look for scholarships?

Remember that your 21st Century Scholarship can cover up to full tuition and mandatory fees, but even if you receive full tuition, this award does not cover expenses such as room and board, books and supplies. Unlike loans, scholarships do not have to be paid back and can help cover other costs not covered by your 21st Century Scholarship.

### What type of scholarships are available?

As you search for scholarships, remember there are two basic types of scholarships, merit and need-based.

**1. START** by talking with your school counselor. They will often have a list of local and national scholarships that you can start your search with.

**2. EXPLORE** local scholarship opportunities. Check with local civic groups and community foundations to see what scholarships are available.

**3. CHECK OUT** the financial aid websites of schools and universities you are interested in for scholarship opportunities. If you already know of a program or major you're interested in, check that department's page for potential scholarships.

**4. SEARCH** online scholarship platforms to find more possibilities. Below is a short list of sites to explore:

### How do I maintain the Scholar Pledge and keep my scholarship?

See the 21st Century Scholar Pledge Requirements on page 2.

### What should I do if I change schools or my contact information changes?

Log in to your ScholarTrack account and make the necessary changes so you do not miss notifications and updates from the 21st Century Scholars program.

## Do I have to file the FAFSA every year in high school?

No. You must complete the FAFSA (Free Application for Federal Student Aid) during your last year of high school and each year (minus your last year) that you are to be enrolled in college.

### If I graduate early, can I still use the **21**st Century Scholarship?

Yes! If you plan to graduate early, notify your school counselor so they can inform the 21st Century Scholars program. You must complete all 12 SSP activities, including filing the FAFSA by April 15 of your last year in high school. If you plan to graduate early, learn about the Mitch Daniels Early Graduation Scholarship at learnmoreindiana.org/financial-aid/ scholarships

### Can I use my scholarship to pay for dual-credit classes while in high school?

No. The scholarship is only available once you have graduated high school.

### If my GPA falls below 2.5 for a semester, will I lose the scholarship?

You are still eligible for your scholarship if your overall GPA is at least 2.5 on a 4-point scale at the time of your graduation.

### Can I receive the scholarship if I complete a high school equivalency exam (GED or TASC) or complete home school?

No. You must receive at least a Core 40 or an Indiana Diploma (Class of 2029 and beyond) from an eligible high school recognized by the Indiana Department of Education.

### What happens if I don't complete the SSP on time?

You must verify that you've completed all 12 SSP activities by June 30 of your graduation year. Your scholarship cannot be awarded until all activities are complete.

### Am I still eligible for my scholarship if I take a gap year?

Yes, but you must be enrolled in a postsecondary education institution no later than a year after you graduate high school.
